Upon termination of employment, whether voluntary or involuntary, the standard HSA fee schedule will apply.


² Charged for each day your account is overdrawn; not charged if negative balance is eliminated within 3 business days after the day of the overdraft occurrence.

³ Fee is charged and deducted at the time the account is closed. Fee will not be charged if the account is open and active for more than 180 days.

⁴ See individual Prospectus for fees related to each Mutual Fund available through the Health Investment Account (HIA). Must have a minimum balance of \$2,000 in Health Savings Account to establish HIA. An Investment Administration Fee totaling 10 basis points annually will be assessed. Quarterly 2.5 basis points or 0.025% of the total average investment account balance will be applied to the standard HSA account fees at the end of each calendar quarter.
